This is to inform that the Company has received an Income Tax notice along with an Assessment Order ("Order") for the assessment year 2020-21 from the Income Tax Department, raising a demand of Rs.233.66 Crores (including interest).

In the view of the Company and based on legal advice, these claims are non-tenable based on past precedents in the Company's own cases and other judicial pronouncements. The Company does not consider it likely that this demand will devolve or materialise as a claim against the Company and result in a liability.

The Company will be contesting the demand before the Appellate authorities and will take adequate steps to safeguard its interests.

The Company will update the stock exchanges of material developments, if any, in the aforesaid matter in future.
